2024 REGISTRATION AND EMPLOYEE SAFETY CONDITIONS

Prior to providing farm labor services within Riverside County during 2024, please complete and sign the enclosed registration form. You will be assigned a registration number for 2024. There is a **\$40.00** fee for this registration. Make a check payable to the County of Riverside. Return the **\$40.00** fee, complete registration form, and a photocopy of your valid State of California Farm Labor Contractors License to your local district office of the Riverside County Agricultural Commissioner. **PLEASE NOTE, YOUR COUNTY OF RIVERSIDE REGISTRATION EXPIRATION DATE WILL NOW COINCIDE WITH THE EXPIRATION DATE ON YOUR FARM LABOR CONTRACTORS LICENSE. PLEASE SUBMIT A COPY OF YOUR RENEWED LICENSE TO OUR OFFICE TO EXTEND YOUR REGISTRATION EXPIRATION DATE.**

For your convenience you can now pay online @ www.rivcoawm.org. IF FEES PAID ONLINE, REGISTRATION FORMS ARE STILL REQUIRED TO BE SUBMITTED TO OUR OFFICE.

You must maintain a copy of your most current license (with an expiration date that will apply for the 2024 calendar year) with our office. You may fax or mail a copy each time your license is renewed. If the current license is not on file, your registration will be null and void.

A copy of the registration will be returned so that you will have copies for your foreman to present during any field worker safety inspections.

Farm Labor contractors should furnish a copy of the registration to each field foreman and to each grower with whom he/she contracts. If you have questions about these conditions, contact your local district office.

All mail must be sent to P.O. Box 1089, Riverside CA 92502-1089 or it will be returned.

IF FEES ARE PAID ONLINE, REGISTRATION FORMS ARE STILL REQUIRED TO BE SUBMITTED TO OUR OFFICE.

BEGINNING 2021/22, THE AGRICULTURAL COMMISSIONER'S OFFICE WILL NO LONGER BE MAILING COURTESY REGISTRATION FORMS.
